What is the overall <u>deductible</u> ?	<u>In-network</u> : \$2,500 Individual / \$5,000 Family. <u>Out-of-network</u> : \$5,000 Individual.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u> ?	Yes. Does not apply to <u>copayments</u> , <u>prescription drugs</u> , <u>preventive care</u> and services listed below as "No charge". Does this plan provide Minimum Essential Coverage? **Yes.**
